Enbridge Home Efficiency Rebate

Get up to **\$5,000**

back for making energy efficiency upgrades

- Complete a minimum of **two upgrades, or three upgrades if a furnace is chosen**
- Home must be heated with a natural gas furnace or boiler
- Maximum total Enbridge Gas rebate is \$5000**
- All work and final assessment must be completed within **120 days of initial assessment.**
- Each Service Organization provides the same customer experience and will be able to facilitate the rebate on the customer's behalf. Upon successful completion, Enbridge Gas will include a \$550 reimbursement on the customer's final incentive cheque to offset the cost of both energy assessments.

ENBRIDGE GAS INCENTIVES: at least two of these upgrades must be undertaken to qualify for incentives

Air Sealing	<p>\$100 - For reaching target on report</p> <p>\$150 - For reaching 10% above target on report</p>	Note: Baseline calculation is done during the initial assessment
Attic Insulation	<p>\$500 - For increasing attic insulation to least R60 from R35 or less</p> <p>- For increasing cathedral/flatroof insulation by at least R14</p>	Note: Minimum 20% of total ceiling area must be upgraded. Rebates are pro-rated based on the total ceiling area % upgraded.
Basement Insulation	<p>\$1,000 - For adding at least R23 to 100% of basement</p> <p>\$500 - For adding at least R12 to 100% of basement</p> <p>\$800 - For adding at least R23 to 100% of crawl space wall</p> <p>\$400 - For adding at least R10 to 100% of crawl space wall</p> <p>\$450 - For adding at least R24 to 100% of floor above crawl space</p>	Note: Minimum 20% of total basement wall area must be upgraded. Rebates are pro-rated based on the total combined % area upgraded.
Exterior Wall Insulation	<p>\$1,000 - Add at least R3.8 to 100% of building to achieve a minimum of R12</p> <p>\$1,500 - Add at least R9 to 100% of building to achieve a minimum of R12</p> <p>\$2,000 - Add at least R20 to 100% of building</p>	Note: Minimum 20% of total wall area must be upgraded. Rebates are pro-rated based on the total wall area % upgraded. Homes with less than 2x4 structure are exempt from R12 minimum with photo documentation of wall structure.
Furnace	<p>\$500 - For replacing a natural gas furnace that is <96% efficiency with a natural gas furnace that is 96% AFUE or higher + 2 other measures</p>	
Boiler, combi unit will only count as one measure	\$1,000 - For replacing a natural gas boiler that is <90% efficiency with an ENERGY STAR® condensing natural gas boiler that is 90% AFUE or higher	
Water Heater	<p>\$200 - For replacing existing natural gas water heater with 0.80 EF or higher tank type ENERGY STAR® qualified natural gas water heater</p> <p>- For replacing existing natural gas water heater with 0.90 EF or higher tankless type ENERGY STAR® qualified natural gas water heater</p>	
Window/door/Skylight	\$40 - For each window, door or skylight replaced with an ENERGY STAR® Certified model	

ADDITIONAL BONUS INCENTIVES:

Available for Deeper Energy Savings as part of the maximum \$5,000 Enbridge Gas incentives

- Install 3 upgrades** - customer will receive additional **\$250**
- Install 4 upgrades** - customer will receive additional **\$500**
- Install 5 upgrades** - customer will receive additional **\$750**

To qualify for the Home Efficiency Rebate, homeowners must also agree not to participate in any other gas or building envelope rebate(s) offered by parties outside of Enbridge Gas Inc. between the initial and final assessments. Natural gas fuel savings are based on approved modeling software. Only one enrollment for incentive per household is permitted. To find out if you qualify for incentives, an initial and final home energy assessment is required by an approved Registered Energy Advisor (REA). No more than 120 days between assessments is allowed. If more time is needed to complete your upgrades, simply speak with you REA and they can request an extension. Please contact one of the Enbridge approved Service Organizations listed at enbridgesmartsavings.com/energyadvisor for further information. The Home Efficiency Rebate is only available for residential detached homes, row towns and semis - no multi-residential buildings or condos.
